# 3.1 Operational Capacity and Sustainability - 8:33 AM

## **Budget Considerations**

Ms. Easterly Martey updated the Committee regarding the proposed \$5 million Tax Credit Program increase. It was actively being considered by the senate for inclusion in the state

budget. She added that the result would have implications for the budget, particularly for sustaining the current level staffing following the sunset of CDBG-CV and CCIP. The Committee discussed whether to consider different budget scenarios.

Mr. Rayno joined the meeting at 8:36.

The members of the Executive Committee affirmed that they were available to support CDFA when called upon. The Committee then made plans to meet again on at 2:00 p.m. on May 21.

# **Operational Goals**

Ms. Easterly Martey updated the Committee regarding childcare contract work valued at approximately \$200 thousand per year for two years. The Committee discussed administrative requirements of this new work, which builds on the completing pilot program.

# Living Strategic Plan

Ms. Easterly Martey discussed the history of the current iteration of the Living Strategic Plan. The Plan put forward in 2022 was operational but was more of a work plan and less something that was higher level/visionary. Last year the Board helped develop the New York Times piece, which was certainly visionary. For this year's update, CDFA was interested in developing case studies that built on the NH Fiscal Policy Institute conversation and highlighted achievements.

#### Governance

Ms. Easterly Martey informed the Committee the Board's Organized Labor Seat had been filled by Cullen Tiernan, Political Director at SEA/SEIU Local 1984. The remaining vacant Board seats with seats designated to Employment Training Programs and Community Development
