Mr. Claffin called the meeting to order at 10:04 AM. Mr. Claffin noted there were no announcements; there were no members of the public in attendance. There was no public comment.

Mr. Hart provided the Committee with an update on the FY 2023 annual audit. The firm Leone, McDonnell & Roberts had returned to provide the in-house services. Mr. Hart noted that it was both his first audit and Ms. Kim Pacocha's first audit in her new role as Director of Accounting, and it had been a valuable learning experience to-date. The firm would present the audit at the September 19, 2023 Annual Meeting.
